- (2) First you have to download Registration form from university website : www.vnsgu.ac.in As per rules all the required information mentioned in Registration form is to be filled, thereafter your Registration form (with relevant documents) duly checked by the Post Graduate Section (Room No. 121) from the University office and deposit following fees in cash at the cash counter of the Account section between 11.00 a.m. to 2.30 p.m. and 3.00 p.m. to 4.00 p.m. on university working days on or before **17th January, 2017**. If you will fail to remit the Registration fee and Other Fees in time, It shall be presume that you are not interested in availing of the above mentioned admission / registration and the same will be treated as cancelled.
- (3) Once you have completed Registration process, you shall collect your Registration Certificate within (15) days from Post Graduate Section (Room No. 121) of the University.

ELIGIBILITY CERTIFICATE FOR OTHER UNIVERSITY STUDENT :


