It was resolved

1. to calculate API from the academic year 2009-10 for incumbent Professor/Principal.
2. to calculate API from date on which the candidate was appointed/designated on the post of Associate Professor.
3. to get clarification of the state government for the candidates who got the scale of 37400-67000 + 9000 AGP but not designated as Associate Professor.
4. to get clarification of the state government for date from which consolidated API shall be considered/calculated for direct recruitment of Principal as mentioned in UGC Regulation, 2010 Appendix – III Table – II(c).

With the permission of chair, UGC notification on minimum qualifications for appointment of teachers and other academic staff in the Universities and Colleges and measures for the maintenance of standards in higher education (3rd Amendment), Regulation, 2016, dated 4th May 2016 was presented before the member of IQAC for discussion.
