After the introduction of all the members, discussion on agenda began. After thorough discussion, following decisions were taken unanimously by IQAC.

- 2. To discuss the NAAC Peer Team Report.

NAAC Peer Team Report (PTR) of 3rd Cycle was presented before IQAC members. After thorough discussion and deliberations, the following suggestions were made by IQAC to address the suggestions made by the peer team.

- a) To address the issue of International students' accommodation, it was resolved that at the time of planning new hostel building appropriate kitchen facility may be created and provided to students. This facility may be made available to other students' as well on request.
- b) To prepare perspective plan of the University, a committee of the following member was appointed

- c) Vocational programs may be started on the campus & to frame the modality to start vocational program a committee of the following members was appointed
 - 1. Dr. Kiran Pandya
 - 2. Dr. Gaurang Rami
- d) Skill Development Centre should be started on the campus. Hon. VC was authorized to form a committee to establish Skill Development Centre and its report shall be put before the syndicate for further approval and action.
- e) A formal "Placement and Industry liaisoning Cell" should be established.
- To discuss API calculation and its approval methodology for the principals.

It was approved to verify API scores of Associate Professor and principals of Self-finance colleges affiliated with VNSGU. API verification certificate will be issued jointly by IQAC Director and Registrar of the university after verification of API score by API calculation /verification committee.

Further, it was resolved that for the API score for the post of principal in self-finance college, the 4th amendment must be considered.

To discuss the letter of Higher Education Department No. OW/ISC-7/S.
 U./Readers/2016/15813. Dtd. 19/10/2017 regarding pay scale drawing of the Associate professor to Direct Recruiter Readers on or after 01/01/2006.

It was resolved that the letter of Department of Higher Education OW/ISC-7/S.U./Readers/2016/15813 dated 19/10/2016 be accepted and the general section and the account section of the University be directed to immediately initiate the process of recovery of directly recruited readers appointed after 1/1/2006 as per the direction of the letter of Department of Higher Education.

Further, it was resolved that in such cases the date of re-designation of such readers as associate professor be fixed on completion of three years as a reader and subsequent benefits be given as per new fixed dates.

5. It was resolved to authorize hon. Vice-chancellor to appoint a committee to study and suggest a common policy to address issues of agenda (5) and (6).
