CIRCULAR

Regulations for Admission of International Students on Supernumerary Seats Introduction

- Reference:** 1. UGC Notification Dated:24-04-2024, Resolution F.No.1-2/2023(IC)
2. Board of Management (BOM) Dated:20-06-2024, Resolution No.(8.1)

In consonance with the University Grants Commission (UGC) Guidelines for Admission and Creation of Supernumerary Seats for International Students in Undergraduate and Postgraduate Programs in Higher Educational Institutions (HEIs) in India, Veer Narmad South Gujarat University (VNSGU), Surat, establishes these regulations governing the admission of international students to supernumerary seats in its undergraduate and postgraduate programs.

Objectives

1. To expedite and simplify the admission process for international students.
2. To cultivate a hospitable environment that attracts international students to VNSGU.
3. To position VNSGU as a premier destination for international education.

Regulations

1. **Eligibility** : International students possessing qualifications deemed equivalent to the requisite entrance qualifications for their chosen program at VNSGU will be eligible for admission. Students will be admitted provisionally and their admission shall be finalized on the production of an equivalence certificate from AIU, In case the student fails to provide an equivalence certificate the provisional admission allotted to the student shall stand cancelled at any stage. University may verify the documents produced by the student to check and verify the documents from the issuing authorities and in case any discrepancy is found at any stage, the admission of the student shall be cancelled.
2. **Supernumerary Seats**: VNSGU may establish up to twenty-five percent (25%) supernumerary seats for international students, exceeding the sanctioned enrollment for undergraduate and postgraduate programs. This decision is subject to the approval of VNSGU's statutory bodies and will consider available infrastructure, faculty expertise, and other pertinent factors.

3. **Exclusion:** The 25% supernumerary seats are exclusively designated for international students and do not encompass students admitted through exchange programs or Memoranda of Understanding (MoUs) between institutions or between the Government of India and other countries.
4. **Fees:** for UG Programs 2000 dollars and for PG programs 3000 dollars per year.
5. **Seat Distribution:** VNSGU will strive to distribute the 25% supernumerary seats across various departments, schools, centers, or other academic units based on infrastructure and the availability of qualified faculty.
6. **Seat Allocation:** Supernumerary seats are reserved solely for international students (**defined as those holding foreign passports**) in undergraduate and postgraduate programs. Unfilled supernumerary seats will not be allocated to domestic students.
7. **Formalization:** The creation of supernumerary seats for international students will be formalized through approval by VNSGU's statutory bodies, adhering to UGC and other regulatory body guidelines.
8. **Professional and Technical Institutes:** Supernumerary seats in professional and technical institutes will be governed by their respective statutory bodies.
9. **Ph.D. Programs:** Regulations for supernumerary seats in Ph.D. programs will be governed by separate regulations notified by the UGC.
10. **Office of International Students:** VNSGU will establish an Office of International Students to manage and maintain comprehensive year-wise data on international students, including their country of origin, program of study, and duration of study. This data will be readily accessible on the university website.
11. **Admission Information:** VNSGU will ensure that all details regarding the number of supernumerary seats available for each program, fee structure, admission process, and eligibility criteria are clearly presented on the university website.
12. **Compliance with Government Regulations:** VNSGU will adhere to all existing rules and provisions notified by the Government of India concerning visas, Foreign Regional Registration Offices (FRROs), and other relevant regulations.
