

MEMORANDUM OF UNDERSTANDING

BETWEEN

"All Compliances" (First Part)

AND

"Department of Human Resource Development, Veer Narmad South Gujarat University" (Second Part)

FOR SOCIAL AUDITS AND IMPACT STUDIES

1. Preamble

This Memorandum of Understanding ("MOU") is entered into on this 5th Day of January, 2024 between:

All Compliances Solutions, Proprietorship, Registration Number: 09ACKPV788L1ZA, Jurisdiction office Lucknow Sector - 13, having its registered office at [C-84, SECTOR b, ALIGANJ, LUCKNOW, Uttar Pradesh - 226024] (hereinafter referred to as "All Compliances Solutions")

AND

Department of Human Resource Development, Veer Narmad South Gujarat University, a state university established under the Veer Narmad South Gujarat University Act, 1965], having its registered office at VNSGU Campus, Udhna - Magdalla Road, Surat-395007 (herein after referred to as "Department of Human Resource Development, Veer Narmad South Gujarat University")

2. Background

Both parties recognize the importance of conducting Social Audits and Impact Studies for the betterment of society and the advancement of academic research and development. This MOU establishes the terms and conditions under which All Compliances and the Department of Human Resource Development, Veer Narmad South Gujarat University will collaborate in these endeavors.



3. Objectives

The primary objectives of this association are:

- a. To promote and conduct social audits and impact studies on various aspects of society including but not limited to social, economic, environmental, and cultural dimensions.
- b. To enhance academic research and development by facilitating data collection, analysis, and dissemination of research findings.
- c. To foster collaboration between the academic community and practitioners in the field of social audits and impact studies.

4. Terms of Association

- 4.1 **Collaborative Research:** All Compliances and the Department of Human Resource Development, Veer Narmad South Gujarat University agree to collaborate on research projects related to social audits and impact studies. The specific details of each research project, including objectives, responsibilities, funding, and timelines, will be documented in separate agreements as necessary.
- 4.2 **Resource Sharing:** Both parties may share resources, including but not limited to research facilities, data, personnel, and equipment, as required for the successful execution of collaborative projects.
- 4.3 **Publication and Dissemination:** All research findings and publications resulting from this association will be jointly owned by All Compliances and the Department of Human Resource Development, Veer Narmad South Gujarat University. Both parties will have the right to use and disseminate the findings for academic and public benefit, subject to any legal obligations or agreements.
- 4.4 **Financial Arrangements:** "All Compliances" agrees to bear all financial burden in the marketing of services and execution of projects.
- 4.5 **Confidentiality:** Both parties acknowledge the importance of maintaining the confidentiality of sensitive information and data. Any confidential information shared during collaboration will be protected according to applicable laws and regulations.

5. Duration and Termination

This MOU shall be in effect from the date of its execution and shall remain in force until either party provides written notice of termination to the other party. Termination shall be effective after a Notice Period of 30 days (30 days after receipt of notice) of the written notice.

6. Governing Law and Jurisdiction

This MOU shall be governed by and construed by the laws of Jurisdiction of Surat, Gujarat. Any disputes arising under or in connection with this MOU shall be subject to the exclusive jurisdiction of the Surat courts.

Amendments

This MOU may be amended or modified in writing by mutual agreement of both parties.
