

MEMORANDUM OF AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

This Memorandum of Agreement is made this September 25, 2021 by and between:

SCHOOL OF GRADUATE STUDIES - MINDANAO STATE UNIVERSITY
GENERAL SANTOS CITY with official address at Laurel Street, General Santos City
represented by its Chancellor, **ANSHARI P. ALLI, Ph.D**, hereinafter referred to as the **FIRST PARTY**;

and

The **VEER NARMAD SOUTH GUJARAT UNIVERSITY**, with agency
address at Department of Economics, Social Sciences Building, Udhna Magdalla Road Surat -
395 007, GUJARAT - INDIA, represented herein by Professor, **RAMI GAURANG**
DATTUBHAI, Ph.D. hereinafter referred to as the **SECOND PARTY**.

WITNESSETH:

WHEREAS, the **FIRST PARTY** provides equitable and relevant educational opportunities through quality instruction; and responsive research and development endeavours, in order to produce professional, skilled, morally upright and globally competitive teachers.

WHEREAS, the **FIRST PARTY** and the **SECOND PARTY** are committed to provide mutual support to establish linkage and cooperation in order to maximize utilization of his/her expertise through instruction, and research. The teaching arrangement could also include team teaching and membership in Accreditation Committees.

WHEREAS, the **FIRST PARTY** and the **SECOND PARTY** agreed that any outputs, publication or any copyrightable work produced by virtue and pursuant to this Agreement shall be owned jointly by MSU School of Graduate Studies and Veer Narmad South Gujarat University.

WHEREAS, both **PARTIES** acknowledge that there is a contractual relationship made and agree to work together in the true spirit of collaboration to ensure that there are evident and responsive mechanisms to show administrative, and managerial commitment to the implementation of the activity through the services to be rendered by both parties. The compensation shall be arranged at Php 1000 per hour with applicable tax deductions for Filipino citizens residing in the Philippines.

WHEREAS, both **PARTIES** agreed that other services could be explored such as training to teachers and students; research collaboration with resident faculty; co-authorships; thesis review; editorship of publications; peer review of journals as deemed necessary, shall be completed within a period of one (1) year.

NOW, THEREFORE, in consideration of the foregoing, the PARTIES agree to the following:

1. The **FIRST PARTY** will:
 - 1.1 Provide Learning Management System (LMS) for the conduct of students' academic classes;
 - 1.2 Pay compensation based on approved and existing rates or fees;
 - 1.3 Provide online assistance in the planning and execution of the online classes; and
 - 1.4 Agree to the second party where the research paper can be presented or published Internationally.
2. The **SECOND PARTY** will:
 - 1.1 Act as Adjunct Faculty in MSU-School of Graduate Studies;
 - 1.2 Collaborate in the design of courses for instruction as well as in the conduct of the research, if needed;
 - 1.3 Submit grades, test questions, or other essential materials,
 - 1.4 Abide by all of the MSU-GSC policies and procedures including the Adjunct Faculty submission of pertinent documents such as Curriculum Vitae, Transcript of Record and Letter of Intention to Teach;
 - 1.5 Participate in SGS Online Faculty workshops, trainings, etc., as required by the Dean or the Dean's designee.
 - 1.7 The Adjunct agrees that his/her name may be listed as an **Adjunct Faculty** in MSU GSC publications such as the website, catalogues, etc.

This AGREEMENT shall be valid for one (1) year and shall take effect immediately upon signing.


