



MEMORANDUM OF UNDERSTANDING

BETWEEN

MOUNTAIN PROVINCE STATE UNIVERSITY, PHILIPPINES

AND

VEER NARMAD SOUTH GUJARAT UNIVERSITY, INDIA

MOUNTAIN PROVINCE STATE UNIVERSITY, PHILIPPINE, and VEER NARMAD SOUTH GUJARAT UNIVERSITY, INDIA agree to enter into a formal partnership agreement based on the foundation of mutual trust for the mutual benefit and development of the two institutions and the promotion of international understanding and goodwill.

1. The two institutions resolve to exercise reasonable efforts to execute the following programs:
 - (1) Exchange of students;
 - (2) Exchange of faculty and researchers;
 - (3) Extend the expertise of qualified faculty members as Adjunct Faculty;
 - (4) Exchange of academic information and publications;
 - (5) Joint research activities;
 - (6) Joint organizers of international research and publications;
 - (7) Other exchanges of academic and cultural nature agreed upon by both parties.
2. The implementation of exchange based on this agreement shall be separately negotiated and determined by both institutions.
3. Nothing shall diminish the complete autonomy of either institution nor will any constraint or financial obligation be imposed by either upon the other in carrying out the agreement.
4. This agreement is effective when the representatives of both institutions have signed and dated the document subject to the approval of the respective governing bodies.
5. The implementation of this understanding is in line with the Sustainable Development Goals (SDGs), also known as the Global Goals adopted by the United Nations in 2015 as a universal call to action to end poverty, protect the planet, and ensure that by 2030 all people enjoy peace and prosperity guides the closer involvement of MPSPC's academic collaboration to build a strong reputation along the Sustainable Development Goals (SDG) pillars of No Poverty, Good Health and Well-Being, Gender Equality, Decent Work, Economic Growth, Sustainable Cities and Economies, Peace, Justice and Strong Institutions and Partnership for the Goals.
6. The agreement will remain in force for five (5) years. Any revision or renewal of the agreement is subject to mutual consent. It is also understood that either institution may terminate the agreement at any time by giving written notice at least six (6) months before the intended date of termination, although such action will only be taken after mutual consultation to avoid any possible inconvenience to all parties.
