
The said trust has agreed to offer the same to the party of the second part and the second part is agreeing on the terms and conditions hereinafter appearing .

The learning process at Osho Chair shall be based on the dimensions of holistic growth in human life . Accordingly , the AIMS and OBJECTIVES of the Osho Chair Shall be as under:

- To offer as it Would be required various education programs for empowering the individual for improving one's physical and intellectual capabilities by learning techniques of Meditation for personal growth. And to offer in house and external training programs at different organizations/places.
  - To carry out seminars, workshops, Academic programmes or any other relevant activity etc. for promoting basic objectives of the Osho Chair.
  - To invite distinguished speakers/outstanding personalities to speak on a subject relevant to Osho and his vision
  - To conduct/Facilitate Osho Meditation events/residential meditation camps at institutes of learning and at different organizations, business or work places.
  - To carry out assignments of teaching meditations and therapies.
  - To carry out research, publications and extensive activity related to the aims and objectives of chair.
2. (a) Interest of the amount deposited by the Donor shall be utilized for the activities under Osho Chair.
  - (b) The income generated through the activities of the Osho Chair will be deposited in the bank account of Osho Chair.
  - (c) In case the expenditure for any activity under Osho Chair exceeds the amount generated from the activity, interest of the amount deposited and donation, the Donor will be responsible for the additional expenses.
  - 3 The name Osho Chair as proposed by the Donor shall not be changed by the University without consultation and acceptance of Osho Lotus.
  - 4 The Osho Chair shall be managed by managing committee/advisory committee consisting of following members.
    - (a) Three members from the University nominated by the vice chancellor.
    - (b) Three Representative of the Donor nominated by the Donor/Trust
    - (c) The Chairman of the committee shall be from three members of the University.
  5. The osho chair shall observe all the provisions of the Government of Gujarat and the Veer Narmad South Gujarat University Act., statute ,ordinance , Norms etc.






