CORRIGENDUM

Reference: Employment Notice No. GAD/EmpNotice/14041/2026, dated 24/06/2026 for the post of Finance and Accounts Officer

In partial modification of the Employment Notice referred to above, it is hereby notified for the information of all concerned that the **Minimum Qualifications (Educational Qualifications and Experience)** prescribed for the **post of Finance and Accounts Officer** have been revised, as directed by the Competent Authority, in accordance with the UGC Notification D.O. No. 9-35/2016 (CPP-II) dated 15-04-2021.

Accordingly, the revised minimum qualification criteria shall be read as follows:

REVISED MINIMUM QUALIFICATIONS

1. Master's Degree with at least 55% marks or an equivalent grade in a point scale wherever grading system is followed.

Provided that a relaxation of 5% marks shall be allowed to candidates belonging to SC, ST, SEBC (Non-Creamy Layer), PwD and such other categories as may be prescribed by the UGC/Government from time to time. Accordingly, such candidates shall be eligible with a minimum of 50% marks at the Master's Degree level.

OR

1. Possess degree of Chartered Accountant/Cost Accountant awarded by ICAI/ICMAI (erstwhile ICWAI)
2. At least 15 years of experience as Assistant Professor in Academic Level-11 and above or with 08 years of service in Academic Level-12 and above including as Associate Professor, along with experience in educational administration;

OR

2. Comparable experience in Research Establishment and/or other Institutions of Higher Education;

OR

2. 15 years of administrative experience, of which 08 years shall be as Deputy Registrar or an equivalent post.

OR

2. 15 years of experience involving sound knowledge of Central Govt. Rules relating to Accounts/Audit. Service Conditions, Treasury and Finance, out of which at least 8 years' experience in the Pay Level 12 or above.

OR

2. 15 years' experience in Accounting and Auditing firm, out of which 10 years' experience after obtaining the degree of Chartered Accountant/Cost Accountant.

Note: Candidate has to produce a copy of Certificate Of Practice (COP) in case of professional practice/Certificate of experience.

3. At the time of appointment selected candidate possesses a certificate of basic knowledge of computer application of any institute as per resolution No. CRR-10-2007-120320-G5, dt. 13/08/2008 and dt. 18/03/2016 of General Administrative Department, Gandhinagar.

All other terms and conditions, including age limits, application fees, mode of application, and the last date for submission of applications, as specified in the Employment Notice dated 24-06-2026, shall remain unchanged.
