This MEMORANDUM OF UNDERSTANDING is made on this 7th Day of JAN, 2017

BETWEEN

INSPECTOR GENERAL OF POLICE, SURAT RANGE having his office at Nr. Police Head Quarters, Nr. Ichchanath Mahadev Temple, Athwa Lines, Surat-395001 represented by Dr. Shamsheer Singh, IPS, Inspector General of Police, Surat Range (hereinafter to be referred to as the SURAT RANGE POLICE) the party of the FIRST PART.




VEER NARMAD SOUTH GUJARAT UNIVERSITY, a State University established under the Veer Narmad South Gujarat University Act, 1965 having its office at: Udhna-Magdalla Road, Surat-395007, represented by Shri Arvind Dhaduk, In Charge Registers, (hereinafter to refer to as the **VEER NARMAD SOUTH GUJARAT UNIVERSITY**, the party of the **SECOND PART**)

WHEREAS the party of the First Part has decided to partner with Academic Institutions for improving the existing policing systems, improving the police interaction with citizens, preparing citizen centric policing plans and policies, preparing Standard Operating Procedures (SOPs) for investigation & other activities, appraisal of performance of Police Officers, identification and adoption of best practices, identification and adoption of technology in policing, designing Community Policing Programs, evaluation of outcomes of various Community Policing Programs, Research & Development, identification of training needs of officers at various levels and preparing required training modules, content development and faculty support for training of Police Officers, Internship Programs for Under Graduate and Post Graduate students from the Department of Law, Department of Management, Department of Sociology, Department of Computer Science & Department of Public Administration as part of **Model Range Project** for capacity building and for improving the delivery and quality of security services by all the five Districts falling under the jurisdiction of Surat Range.

AND WHEREAS at present the party of the First Part has limited infrastructure for above activities and hence, the party of the First Part has approached the **VEER NARMAD SOUTH GUJARAT UNIVERSITY, SURAT** and **WHEREAS** the **VEER NARMAD SOUTH GUJARAT UNIVERSITY** is ready to partner with **SURAT RANGE POLICE** for sharing its academic infrastructure including Class Rooms, Library, Faculty for various activities proposed by the **SURAT RANGE POLICE** as mentioned above for improving the delivery and quality of security services in all the five Districts falling under its jurisdiction.

AND WHEREAS both the parties have inter-say agreed on the following terms and conditions:





TERMS AND CONDITIONS

1. The **VEER NARMAD SOUTH GUJARAT UNIVERSITY** will provide access to its academic infrastructure to the First Part free of cost for the purpose of conducting training, organizing workshops, seminars for the benefit of the Police Officers of five Districts falling under the jurisdiction of the SURAT RANGE. However, food & beverages' charge and the Hostel charges will be payable as per the policy of the VNSGU, SURAT.
2. The **VEER NARMAD SOUTH GUJARAT UNIVERSITY** will provide academic support for improving of existing policing systems, improving the police interaction with citizen, preparing citizen centric policing plans and policies, preparing Standard Operating Procedures (SOPs) for investigation & other activities, designing effective Performance Appraisal Systems for Police Officers.
3. The **VEER NARMAD SOUTH GUJARAT UNIVERSITY** will provide faculty support for designing Community policing Programs, evaluation of outcomes of various Community Policing Programs, Research & Development, content development and faculty support for training of Police Officers
4. The **SURAT RANGE POLICE** will support Internship Programs for Under Graduate and Post Graduate students from the Department of Law, Department of Management, Department of Sociology, Department of Computer Science & Department of Public Administration etc. by providing access to Police Stations, District Police Offices, Surat Range Office and various other police activates. The **VEER NARMAD SOUTH GUJARAT UNIVERSITY** and the **SURAT RANGE POLICE** will work out the duration, content, certification and other modalities of the internship programs through the process of mutual consultations
5. The **SURAT RANGE POLICE** will provide access district training centre falling under the jurisdiction of the SURAT RANGE to the Second Part free of cost for the purpose of conducting training, organizing workshops, seminars for the benefit of the Students of The **VEER NARMAD SOUTH GUJARAT UNIVERSITY** subject to availability.


6. The **VEER NARMAD SOUTH GUJARAT UNIVERSITY** and the **SURAT RANGE POLICE** may appoint Program Coordinators who will interact regularly for the smooth conduct of various activities, including Internship Programs and periodic review of the outcomes of various programs
7. The party of the First Part Shall provide access to various police records, statistical information, crime database etc for the purpose of academic studies, research and development. However, the access to certain police records, statistical information may be denied if they are classified as TOP SECRET, SECRET, CONFIDENTIAL and access to certain police records, statistical information may also be denied on the grounds of operational secrecy.
8. The Documents, research paper, reports or other documents produced by the members of the faculty, students and the administrative officers of **VEER NARMAD SOUTH GUJARAT UNIVERSITY** based on the information accessed during any of the above said academic activities shall be the property of the First Part. However, a Screening Committee consisting of representatives of First Part and Second Part may be constituted for identifying Research Reports for publication and the same may be published after obtaining the approval of the Home Department, Government of Gujarat.
9. **WHEREAS**, the documents, research paper, reports or other documents produced as above shall be treated as SECRET and the shall not be published in Journals, periodicals, news papers, social media in printed or electronic form without the prior approval of the **First Part**
10. **The SURAT RANGE POLICE** shall not make any payment to the members of the faculty OR students by way of remunerating, stipend, scholarship, allowance OR payment in any other form for providing any service agreed as above.
11. **WHEREAS**, the party of the First Part will assist the **VEER NARMAD SOUTH GUJARAT UNIVERSITY** by providing the services of Police Officers for sharing their field experiences with the Under Graduate and Post Graduate Students.

12. The Memorandum of Understanding shall be valid for a period of 1-years from the date of signing and the parties may extend the period of validity for a further period as agreed by both the parties with or without amendments to the same. However, it may be terminated on an earlier date with mutual consent of contending parties.

Both the parties hereto have signed, sealed and delivered this memorandum of Understanding in duplicate and both are signed by both the parties and shall always be considered as ORIGINAL.






