1. The candidate who desires to apply for more than one Non-Teaching/Administrative post will be required to apply separate application and an additional application fee along with each application.
2. Candidates applying for the Post of Sr. No. 1 in the advertisement needs to follow the guidelines prescribed by UGC vide Notification dated 18th July 2018 and subsequent amendments from time to time till the last date of receiving application.
3. The appointment of the selected candidate for the post as mentioned on Sr. No. (1) and (2) on regular basis from the grants released by state government shall be subject to the conditions laid down by the state government/university from time to time. Recruitment of Non-teaching/Administrative post as mentioned on Sr. No. (3) to (6) shall be as per Resolution No. KhRCh/2002/57/(Part-4)/z.1, Dated 18-10-2023 of Finance Department, Government of Gujarat on fix pay for the first five years.
4. Applicants must submit the application through online recruitment portal at <https://vnsgunt.samarth.edu.in> on or before dt.03-08-2026 till 6:00 pm and must upload the necessary documents with the online application.

6. The applicant must ensure that he/she fulfills the eligibility conditions for the Post applied as per respective Notifications.
7. In no circumstances any content of the application form should be modified.
8. The prescribed application fee is Rs.500 /- (Five Hundred only) for General Category and 200/- (Two Hundred only) for Scheduled Caste (SC)/ Scheduled Tribe (ST)/ Socially and Economically Backward Class (SEBC)/ Economically Weaker Section (EWS) to be payable online.
