GENERAL INSTRUCTIONS FOR RECRUITMENT OF CONTRACTUAL FACULTY / GUEST SCHOLAR UNDER TAJSP

1. The appointment is purely contractual under the **Tirthankar Ajitnath Jain Study Program (TAJSP)** being implemented at the Center for Hindu Studies, Veer Narmad South Gujarat University, Surat, under the Memorandum of Understanding (MoU) executed between Veer Narmad South Gujarat University and Vardhman Charitable Foundation.
2. The appointment shall initially be for a period of **11 months**. The contract may be extended subject to continuation of the project, satisfactory performance of the candidate, availability of funds, and approval of the competent authority.
3. The selected candidate shall actively participate in all academic, research, extension, seminar, workshop, examination, evaluation, mentoring, outreach, and administrative activities related to TAJSP.
4. The selected Faculty Member / Guest Scholar shall perform duties in accordance with the objectives, roles, responsibilities, and provisions specified in the TAJSP MoU and its annexures.
5. Preference will be given to candidates having specialization in **Jain Studies, Comparative Religion, Indian Philosophy, Hindu Studies, Indian Knowledge Systems (IKS), Sanskrit, Prakrit, Religious Studies, Ethics, History, Culture, or related disciplines**.
6. Keeping in view the objectives of TAJSP, the University reserves the right to shortlist candidates based on their academic credentials, teaching experience, research contributions, publications, and other relevant achievements.
7. The Selection Committee shall be constituted in accordance with the provisions of the MoU and the prevailing rules of the University. The decision of the Selection Committee shall be final and binding.
8. The selected candidate shall abide by the statutes, ordinances, regulations, code of conduct, and other rules of Veer Narmad South Gujarat University as well as the provisions governing TAJSP.

9. This appointment is entirely project-based and contractual in nature. Therefore, the selected candidate shall not have any claim for regular appointment, permanent service, seniority, or any service benefits other than those specifically approved under the project.
10. The selected Guest Scholar shall receive a **consolidated remuneration of ₹1,00,000/- per month** and shall not be entitled to DA, HRA, pension, gratuity, or any other benefits unless specifically approved by the University under applicable rules.
11. The selected candidate shall be responsible for:
 - Teaching courses under TAJSP.
 - Curriculum development and academic planning.
 - Conducting examinations and evaluations.
 - Organizing seminars, workshops, lectures, and outreach activities.
 - Promoting interdisciplinary research in Jain Studies.
 - Maintaining academic records and submitting periodic reports.
 - The Responsibilities assigned by the coordinator or higher authorities.
