This memorandum of association is made and signed at Suart on 22<sup>nd</sup> October 2021

by and between:

1. Almawadi Gram Pandhayat, Taluka Dediypada, district Narmada (here after referred as Almawadi) the elected members and their sucessors.
2. Veer Narmad South Gujarat University, Udhana-Magdalla Road, Surat 395007 (herein after referred as University)

Almawadi and University will referred singly as party and jointly as parties to this memorandum. Both the parties have reached the following intent to collaborate and cooperate as per below described Articles of this MOU.

### **Article 1**

Almawadi is a gram panchayat under Dediypada taluka of Narmada district. The voters of this gram panchayat have elected Sarpanch and other members of the panchayat in elections held during 2016. The main sources of livelihood in the village are agriculture and animal husbandry. Various schemes sponsored by the State and Central Government for the development of the villages are being implemented in the village. There is great scope for development by utilizing the natural and human resources and government schemes through convergence.

Information from the records of the Gram Panchayat, from villagers, information related to the problems of the villagers and it will encourage the villagers for the effective solutions of the problems in personal and group discussions, permit the students to attend Gram Sabha etc. The elected members to the Gram Panchayat will participate in these activities and be helpful in making the process of education and research effective.
