

MEMORANDUM OF UNDERSTANDING (MOU)

AND

INTENSE ACTING WORKSHOP

This Memorandum of Understanding is made and entered into on Saturday, May 20, 2023 between DEPARTMENT OF CONTINUING EDUCATION AND EXTENSION WORK, Veer Narmad South Gujarat University, Udhana Magdalla Road, Surat- 395007 and INTENSE ACTING WORKSHOP.

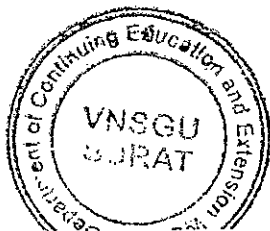
3. OBJECTIVES OF THE MOU

The Government of India has launched NEP 2020 which is focused on educating the youth on Indian Knowledge System with skill based education for employment generation. With reference to NEP 2020, Intense Acting Workshop and DEPARTMENT OF CONTINUING EDUCATION AND EXTENSION WORK, VNSGU, Surat are interested in working together with mutual collaboration to give each other's strengths in teaching, training, research and facilities towards Intense Acting Workshop thereof, will mutually benefit the students and faculties. Now therefore the parties hereto have agreed to enter into a memorandum of understanding considering the long term benefits of sharing the knowledge and resources between the institutes and establish a strong academic collaboration, by undertaking joint responsibilities and activities in their respective field of teaching, training, research, resources, knowledge and excellence.

4. MODES OF COLLABORATION

DEPARTMENT OF CONTINUING EDUCATION AND EXTENSION WORK, VEER NARMAD SOUTH GUJARAT UNIVERSITY, UDHANA MAGDALLA, SURAT- 395007 and INTENSE ACTING WORKSHOP propose to collaborate:

- e. To offer various certificate courses as per rules and regulation of Veer Narmad South Gujarat University to the students.
- f. To offer professional training which make the students employable.
- g. The eligibility criteria for such certificate course and training program will be as per the norms of Veer Narmad South Gujarat University
- h. Any other appropriate mode of interaction agreed between Veer Narmad South Gujarat University and INTENSE ACTING WORKSHOP.



3 CO-ORDINATION AND NODAL OFFICER

Both entities shall mutually decide and designate a nodal officer. The nodal officer will have responsibility for fulfilling the objectives of this agreement and also will carry out all activities mutually agreed by the parties.

4 SCOPE

The Parties acknowledge and agree that the Areas of Collaboration are not exhaustive in nature and the Parties shall in good faith, negotiate to elaborate upon the Areas of Collaboration, including additional areas of collaboration as may be mutually agreed and the rights, responsibilities and obligations of each Party in relation to each of the Areas of Collaboration. The parties may, from time to time, execute addenda or modifications to this MOU to incorporate such additional scope of collaboration or discussions in as per mutual consent.

The Veer Narmad South Gujarat University is empowered to offer certificate courses, to enroll students, to collect fees from the students and issue marksheets to the students as per prevailing norms of Veer Narmad South Gujarat University from time to time.

The Department of Continuing Education and Extension Work, Veer Narmad South Gujarat University, Surat shall have to provide infrastructure and basic facilities to run the certificate courses.

The INTENSE ACTING WORKSHOP shall provide teaching and training to the students enroll in the certificate course and shall conduct the examination of the students as per rules and regulations of the Veer Narmad South Gujarat University with a great confidentiality.

6: DURATION

This MOU shall be valid after its signature from the date of signing till for FIVE years. The Parties may further extend the MOU with mutual written consent, in order to ensure continuous inputs regarding in light of changing trends and environment in the area of collaboration for this MOU. As part of subsequent extensions the Parties may agree to make amendment in the MOU.



7. Finance

The financial arrangements wherever involved will be decided and approved after mutual consent and shall be agreed to for each activity individually on resource deployment, arrangements and mobilization will be planned vis-a-vis.

Veer Narmad South Gujarat University, Surat is empowered to collect the fees from the students enrolled in the certificate courses/training program and the income generated from the collection of fees is to be distributed as per following rules and regulations of the Veer Narmad South Gujarat University, Surat.

- 20% - per students Development Fees to Veer Narmad South Gujarat University, Surat (as per para no.9(C)(9) and 9(C)(10)
- 20% - DEPARTMENT OF CONTINUING EDUCATION AND EXTENSION WORK, Veer Narmad South Gujarat University, Surat for providing infrastructure.
- 60% - Yajat Yoga Group for providing teaching, training, conducting exam etc.

8. Assignment

Neither of the Parties shall assign any of their duties under this MOU to any other person or institution without prior approval of other party. A specific agreement will be entered into for each activity.

9. Amendments

No alterations, additions or modification hereto shall be valid and binding unless the same are reduced to writing and signed by both the Parties.

10. Non-Exclusive Discussions

The Parties acknowledge and agree that the Areas of Collaboration under this MOU are being undertaken on a non-exclusive basis and either Party shall be free to enter into or consummate transactions similar to the Areas of Collaboration with other parties in Bharat or elsewhere.

11. Confidentiality and Public Announcement:

"Confidential Information" means the confidential, proprietary, and trade secret information of the disclosing party to be disclosed by the disclosing party under this MOU, and comprises (a) information in tangible form that:

- (c) (1) bears a Confidentiality Legend, or (2) does not bear any Confidentiality Legend, if the receiving party knew, or reasonably should have known under the circumstances, that the information was confidential and had been communicated to it in confidence, and (b) discussions about that information that may occur before, at the same time, or after disclosure of the information. This MOU and all confidential information exchanged between the Parties pursuant to this MOU shall be held in confidence. Neither Party nor any of the affiliates shall make any public announcement about the MOU and/or the scope of proposed engagement, without the prior written consent of the other Party.



12. TERMINATION

This MOU shall also terminate without liability to either party if otherwise agreed to by the Parties in writing with a notice period of 1 month.




